## ~ Tere Bippes, President:

#### ~ Treasurer:

**Tere Bippes** reported for Mary Wolfe who was away. We are in very good financial shape, \$30,000 in checking, \$99,000 in reserves. We are well within budget, this month spending more on landscape but, less in other areas.

# ~ Richard Martens, Landscaping/Architecture:

- ~ We are running the sprinklers during the day which makes it easier to locate problems. Presently on a 6 day cycle.
- ~ The filter is not functioning as well as hoped and may need to be replaced.
- ~ Request to remind the HOA to put trimmings early on Wednesday in reusable containers or paper bags.
- ~ We will be doing major pruning and trimming. The stump grinding will continue.
- ~ **Steven Bushman** is the parking representative.
- ~ The mole traps are working.
- ~ Working on new landscaping request form for website.
- ~ The golf club is thinking about consolidation the landscaping and having their crews maintain all of Charbonneau.
- ~ Copies of the Reserve Study will be emailed to the HOA.
- ~ Larry Walker is continuing to work on the Q and A for the website.
- ~ Larry Shadle will prepare a Landscape Committee description to be sent to the HOA.

- ~ Cans of the new paint colors are in the pool house, but correct corresponding house/paint colors is not yet properly synced. **Leslie Walker** volunteered to help Larry sort things out.
- ~ Mark Conrad (503 639 9550) is taking care of repairing the brick pillars, at owners expense.
- ~ Friday, September 1 the pool area is being painted and it will be off limits. September 2 the pool will be open again.

## ~ Sandy Batte, Disaster Preparedness:

- ~ A bi-annual pod captain's meeting was held at **Nan Moon's** home.
- ~ Pod captains will be asking residents to provide the first name and phone number of a contact person living east of the Cascades. Information will be held confidential.
- ~ We will be gearing up for the annual Great Shakeout, a statewide event set for 10:19 on 10/19/20. CCC will be using us as a model to help them form a template for the whole community.
- ~ A request was made to purchase a 2 way radio. It will be less than \$100. Short wave people good at networking.
