2017 new Architectural Control Standards

Meeting January 31, 2017 - all homeowner associations and condominiums in Charbonneau were represented.

The following changes were all passed unanimously:

- Rule 21: Motor Home and travel trailer parking added language to limit the number of times (5) that boats, trailers, motorhomes, etc. may park overnight on city streets (where permitted) for the purpose of loading and unloading.
- Rule 10: Patio covers/Arbors/Pergolas Added language stating "Curtains, blinds, drapes or screens on patio covers or pergolas are prohibited."
- Rule 7: Fences/Walls/Lattices/Privacy Screens added vinyl to acceptable materials. Also added languages stating "Free standing privacy screens and/or decorative panels are allowed. These structures must be made from same materials approved for fences or walls and must be approved by the HOA."
- Rule 17: Tree Planting, Pruning, Removal and Replacement stricter language was added regarding the responsibility of owners of trees.
 Language was also added outlining the process to follow if there is a dispute between neighbors regarding pruning or removal of trees.
- Rule 18: Solar Energy Systems added the word shingles to materials approved.
- Section VII. Prohibitions added "Painting of brick and/or stonework on homes and other structures at and adjacent to residential locations.
 Brickwork and stonework are to be left in their natural form."

Other topics

- Use of the Charbonneau logo CCC owns the trademark for the logo
- Several organizations which have the same events every year were given permission to post banners without filing out the paperwork each time i.e. Art Show, SpringRidge Car Show, Alzheimers Fund-raising walk
- · CCAC will meet once per year instead of twice as stated in the guidelines
- Under new business it was suggested the CCAC chair write a letter to the Golf Club President asking them to replace the fence along the maintenance yard.
