- Showplace, and volunteers, did major pruning this week.
- Richard proposed an amendment to our HOAs limiting exterior ornaments that is visible to the neighbors. A motion to table it until next month was made by Tere, and seconded by Leslie.

- They requested an increased amount for food expenses. A motion was made by Musa to increase the funding by \$192, it was seconded by Richard. The motion passed. The money is pulled out of general operating expenses.
- They need tables and Chairs.

~ Sandy Batte, Katie Howe, Disaster Preparedness:

- Katie Howe agreed to co-chair Disaster Preparedness with Sandy
- Sandy, Katie, and several others, attended the Annual CCC Disaster Preparedness meeting.
- Kamran Mesbah is their new chair. The overall responsibility of the committee is "to establish an effective and coordinated approach and response to help minimize the negative effects of a potential disaster for the Charbonneau community."

~ New Business:

- Sandy Batte suggested we have someone review our by-laws for the deductibles on our earthquake insurance. More specific language is needed to define the who is responsible for the deductible on what part of a 'building'...
- Musa made a motion to look into combining the Architecture and Disaster committees, to research information on earthquake deductibles to add to the bylaws. Richard seconded . Richard and Sandy will coordinate.
- Larry Walker is adding a FAQ column to the web page.
- Painting is still in need of completion. Leslie Walker is the new contract person.
- Richard Marten is still working on getting the property lines defined between our HOA landscaping responsibilities and the adjoining HOA's landscaping responsibility. He will be communicating with their new board members.
- Pacific will be looking at our shrubs and keeping them to 5 feet or so hand prune/trim instead of using the power trimmer.
- Decisions about landscaping on common ground... outside of homeowners fence... must be done by the landscapers not by the homeowner.
- Larry Shadle, and several others, met with Schwindt Co. They are updating our reserve study.
- Carole Oliver needs her fence plans reviewed and a large tree trimmed.
