• Tere called the meeting to order.

#### ~ Mary Wolfe, Treasury Report:

- Mary reported that all looks good.
- A couple of people haven't paid their HOA dues.
- Some might need a reminder to contact their bank and update the dues increase.

# ~ Paul Osborn, Landscaping/Architecture:

- We had 71% return on our landscape survey. Seven people asked to be contacted.
- Carole Burnside's roof replacement has been approved by both the Landscape Committee and the HOA board.
- Had a good meeting with Kelly Crouch, Pacific landscaping.
- Pacific neglected mowing on the scheduled Monday this week... which was a dry day. Paul called them on it.
- Talked to the golf course president about coming up with ways to address the soggy spots along the golf course. Proposed we would take the lead and repair the problem if they would agree to pay if it is their irrigation lines. They have not gotten back to Paul. He will get it in writing.
- Good News Tree service will trim 11 of our Japanese maple trees for \$880.

- Will remove a tree from Larry Shadle's property, will replace it with a large shrub. Have gotten permission from CCC.
- Have retrieved several plants from the annex demolition site near the clubhouse and have replanted most along French Prairie.
- Our reserve report suggests we have Nathan make an annual inspection of our trees. Paul and Larry Shadle walked around with Nathan looking at every tree mostly to see if any were in danger of causing property damage. We have good healthy trees.
- Tere said she feels that the landscape committee is doing a fabulous job under Paul's leadership. Great communication, addressing issues, being proactive..Carol, Carole, Paul, Larry, Larry. Thank you.

#### ~ Kenton and Mary Wolfe, Pool:

• Mary reported that Kenton checks the pool area regularly removing moss and cleaning up debris as needed.

- The March community captain's meeting promises to be interesting. There will be fire extinguisher demonstration and maintenance information.

- Medically Trained Residents meet 3 times a year and will have interesting information to share at the March meeting.
- Sandy attended the Friends of French Prairie Forum. Attending were representatives from the Marion and Clackamas counties disaster management program plus other dignitaries. There are interesting long range disaster emergency plans being made for the area.
- CCC is also making long range plans as well...like perhaps buying the boat ramp for water transportation across the river if the bridge is out.

- Sandy said it is too early to clean the roofs. Might suggest spring as a better time frame.
- Suggested we have our insurance reevaluated every 5 years or so for the best deal. Tere reminded that our rates went down 3% this year.
- Sandy is still working the issue with the drainage in front of the Del Monte mail boxes.
- A reminder that Sheri Bates does not want landscaping touching her dead tree which is trimmed as sculpture.
- Paul is considering running the sprinkler system later in the day one time this spring so everyone can check for coverage.
