- There were no Architectural requests submitted in December. Larry reminded homeowners to fill our survey if you request rock or bark dust. We will bark dust after the painting is concluded.

- –Our pool heater is leaking and needs to be replaced. This was in our budget to replace in 2023. Kenton presented the costs estimates. Dick made a motion to approve an expense of \$6400 for anew heater, Larry seconded the motion. Dick also made a motion to approve an expense for \$2500 for a new pump and pool filter. Larry seconded and both motions passed.

- The CCC Emergency committee is looking into options/solutions for the big issues, one being water availability. Sandy said we all need to have a minimum 2-weeks of water in your home for personal and pet use.
